*Greetings my fellow Ruritans!*

*I want everyone to sit a little taller and hold their head up a little higher and be proud, because you are important. You are most important to Ruritan National. Thank you for all you do for our incredible organization.*

*We can only create thriving communities through your efforts. And we can only create thriving communities by thriving ourselves.*

*You should be encouraged by reviewing the statistics. We have welcomed six new clubs into our family. We have had the lowest net loss of members in 15 years, so your bar is set for next year.*

*I point out that we do a good job bringing new members into our family. We gained over 2300 members in the last 12 months, so we just have to find a way to retain those new family members.*

*I commend the board and committees for meeting more frequently. The more time you work on the health of the organization the greater the chance that you will have a healthier organization.*

*I commend my team at the National Office for being reliable, responsive, empathetic and competent.*

*I commend the Budget and Finance Committee for meeting each month. The team continually looks for opportunities to reduce expenses to propose a balanced budget, but there are no longer expenses to be reduced without affecting the benefits that our members see/receive/experience. I challenge all of us to flip our mindset and focus on income generation. The only thing that fixes our budget is opening new clubs, welcoming new members into our current clubs and retaining the members that are in our clubs. Not only will that solve budget issues, which are just the tip of the iceberg, it also ensures that we will be a healthy, stable, thriving organization creating thriving communities for years to come.*

*We still miss Carroll Lowe's IT help daily at the office. He was instrumental in keeping MMS stable. We would be dead in the water if our membership database breaks down, so we are currently researching ways to ensure our membership database continues to function as needed.*

*The BSA bankruptcy case may be behind us, but the effects are still coming. The Methodist church has made the decision to pull all their charters from the boy scouts. That provides opportunity but also risk for Ruritan. Many clubs have been approached to take over being the charter organization for existing scouts. I advise every club considering being a charter organization to do their due diligence and ensure that a full understanding of what the roles and responsibilities of a charter organization entail.*



*Ruritan National is now the proud sole member of two 501(c)(3) charities. Ruritan National Foundation is our education arm, and the newly established Ruritan National Project FOCUS is our disaster relief and humanitarian aid arm. Project FOCUS received funds from the dissolved OWC to continue disaster relief for Ruritans. To support disaster relief in the future, please make checks payable to Project FOCUS. FOCUS stands for Funding Our Communities Under Stress.*

*Rudy turns 35 years old this year! We will be celebrating his birthday with special promotional items through Shumsky online. Ruritan National will be 95 years young. A special celebration is planned for Founders Day in May where the National Board will be on hand for its Spring meeting.*

*At the 2023 convention we tried something new by offering Ruritan apparel items by special order. Everyone received an order form in their registration bag. Selling apparel by special order ensures that we do not carry unsellable inventory or have to sell inventory at a loss, which is not fiscally responsible. Additionally, offering merchandise by special order will allow us to offer a larger variety of items in the future.*

*Ruritan will be turning 100 years old before we know it. Only together can we ensure that our incredible organization will be here to Create Thriving Communities through our first 100 years, and for many years to come.*

# 2023 National Convention Ballot Issues Voted on by Delegates

## Ballot Item 1 - Approved Board Motion 22-03-06 District Convention Delegate calculation—Adult clubs

*Current:* ARTICLE IV, Section 2 Paragraph D 2. Delegates –Adult Clubs.

*Each adult club shall be entitled to one (1) delegate to the district convention for each 10 club members or major fraction thereof; provided, however, that each member club shall be entitled to at least two (2) delegates at any convention. In the absence of any club delegate from the floor of the district convention, the alternate delegate from the club of the absent delegate shall be entitled to vote.*

**Proposed:** ARTICLE IV, Section 2 Paragraph D 2. Delegates –Adult Clubs.

Each adult club shall be entitled to **one (1) delegate to the district convention for each 5 club members** or major fraction thereof; provided, however, that each member club shall be entitled to at least two (2) delegates at any convention. In the absence of any club delegate from the floor of the district convention, the alternate delegate from the club of the absent delegate shall be entitled to vote.

**RATIONALE:** This change would bring District Convention delegates in line with National Convention delegates as listed in the National Bylaws.

**DISPOSITION:** **PASSED**

## Ballot Item 2 - Approved Board Motion 22-03-07 Order of Parliamentary Authority

*Current:* ARTICLE XV Parliamentary Authority

*The rules contained in the newly revised edition of Robert’s Rules of Order shall govern the meetings of Ruritan National in all cases in which they are applicable and in which they are not in conflict with these bylaws and any special rules of order which the Ruritan adopts.*

**Proposed:** ARTICLE XV Parliamentary Authority

The rules contained within the National Bylaws, Policies and Procedures shall govern this organization in all cases. In the absence of guidance in the National Bylaws, Policies and Procedures the current edition of Robert’s Rules of Order will apply.

**RATIONALE:** This proposes no change in policy but reordering of the current statement to properly show order of authority.

**DISPOSITION:** **PASSED**

# 2023 National Convention Ballot Issues Voted on by Delegates

## **Ballot Item 3** - Approved Board Motion 22-03-08 Method of Notification for Bylaws Amendment

*Current: ARTICLE XVI Amendment of Bylaws*

*Amendments to these bylaws shall only be made at a Ruritan National Convention by two-thirds vote of the delegates present and voting, providing the proposed amendments shall have been presented to and approved by the BOD. Notice of any proposed amendment approved by the BOD shall be published in the Ruritan National Magazine at least 30 days before the opening of the next scheduled Ruritan National Convention.*

**Proposed: ARTICLE XVI Amendment of Bylaws**

Amendments to these bylaws shall only be made at a Ruritan National Convention by two-thirds vote of the delegates present and voting, providing the proposed amendments shall have been presented to and approved by the BOD. **Notice of any proposed amendment approved by the BOD shall be given to all Clubs at least 30 days before the opening of the next scheduled Ruritan National Convention.**

**RATIONALE:** The reason for this motion is to allow for multiple means of notifying delegates of proposed Ballot issues.

**DISPOSITION: PASSED**

## **Ballot Item 4** - Approved Board Motion 22-03-26 Mission Statement

*Current: Article II, Section 2, Mission Statement:*

*“Ruritan National is a national organization dedicated to improving communities and building a better America through Fellowship, Goodwill, and Community Service.”*

**Proposed: Article II, Section 2, Mission Statement:**

“Ruritan is a National Civic Organization whose individual clubs are dedicated to surveying and fulfilling the needs of local communities.”

**RATIONALE:** To provide a clearer and more concise Mission Statement. The motto will remain the same: “Fellowship, Goodwill and Community Service.”

**DISPOSITION: FAILED**

# 2023 Summer Leadership Conference

## August 4-5, 2023 - Dublin, VA

Current Lt. Governors are expensed to this conference. Lt. Governors are required to attend this conference to be eligible for reimbursement of one half of their National Convention expenses.

Current District Governors and Zone Governors are not required to attend this conference but are highly recommended to attend.

President Elect Robin and the Leadership Committee are planning the training around the theme: **“Ruritan Strong”** There will be information that will benefit all Ruritans and how we can become better leaders.

The conference gives Ruritan leaders the opportunity to learn more about their responsibilities, share ideas, express concerns, and plan for the future of the organization.

It also provides an opportunity for leaders to learn about the responsibilities that go along with other leadership positions they may wish to seek and encourages them to move up in their leadership roles. The conference brings Ruritan leaders together to discuss concerns and plan for the future of the organization. Attendees will also learn the latest information about Ruritan programs and procedures. A separate MMS training will be provided Saturday after the conference for those wanting to know more. Please bring your personal devices for a more hands-on approach.

As stated earlier, Lt. Governors are expensed to this conference. Others may attend at their own expense and for a nominal registration fee. Special circumstances such as substitutions will be considered on a case-by-case basis by the Ruritan National President.

1. 2023 District Lt. Governors will be paid ½ of their expenses to the 2024 National Convention in Winston-Salem, NC, provided they complete the requirements below. (This will only apply if the current Lt. Governor becomes the District Governor in 2024.)

2. They attend the 2023 Summer Leadership Conference (unless excused in writing by the National President).

3. They attend the Governors’ Training at the 2024 National Convention.

4. They attend substantially all meetings at the 2024 National Convention.

5. They assist the Ambassadors throughout the 2024 National Convention.

6. The district’s form 990 has been filed with the IRS by the February 15 filing deadline for the fiscal year end of September 30.

\*\*All expense vouchers must be submitted within 90 days after the 2024 National Convention.






### Clarke County Supports First Responders



## Fort Valley Stays Busy!






## Lewistown Enjoys History Lesson






Two of the student winners were present for the program and one read her winning essay.



Robert was an attorney since his admission to the Tennessee Bar on March 3, 1956. He graduated from Greeneville High School with honors in 1945. He attended Tusculum College, graduating with a Bachelor of Arts Degree in 1948. He was in the first call to military duty in 1951 with the Korean Conflict, serving two years, being Post Auditor at Fort Belvoir, VA. After honorable discharge, he entered the College of Law at the University of Tennessee, graduating with a Doctor of Jurisprudence Degree in August 1955. In 1960, he entered private law practice in Kingsport with branch offices in Church Hill, TN, for several years and then in 1987 opened an office in his home community of Baileyton.

In 1948, while employed with Greene County Bank, he became a charter member of the Greeneville Jaycees, his first experience with a civic club, where he held leadership positions. He became a member of the Free and Accepted Masons, out of which he learned more about character and leadership qualities, holding offices in the local Masonic Order, as well as Potentate of the Knoxville Shriners in 1976. For over 40 years, he served in the Imperial Shrine where budgeting for the 22 Children's Hospitals was formulated. In 1954, while a student at the College of law, he was elected to lead the local Chapter of Phi Delta Phi, a legal fraternity.

In 1956, on returning home, he became a member of the Baileyton Ruritan Club, a civic organization devoted to community improvement, later serving as its President. The next year he was elected Lt Governor, then District Governor in 1961; then three-year term as National Director, then National Vice President in 1966 and Ruritan National President in 1967. Through the years since, he continued support for the organization in assistance to Clubs and Districts as well as National Convention Chairman three (3) times, and other special assignments.

In 1962, he was elected President of the Tusculum College Alumni Association and served as Alumni representative on the College Board of Trustees. Subsequently in 1968 he was elected to the College Board, serving nine (9) consecutive years, two as the Treasurer and his final two years as Board Chairman.

He was honored by the College in 1984 with an Honorary Doctor of Laws; in 2005 with the Distinguished Service Award, and in 2011 made a Life Trustee of the College. Out of his experience at the College, he was requested to become a Board Mentor for the Association of Small Colleges and Universities and for several years mentored a number of small colleges in the Nation.

In 1974, he was appointed by Gov. Winfield Dunn to a term on the Tennessee Judicial Council and then in 1977, he was elected a Delegate to the Tennessee Constitutional Convention in Nashville. From 1968 to 1987, he also served as Judge for several preliminary Miss America Pageants in the Southeastern states and from 1972 to 1987, was a member of the Country Music Association and attended their CMA National Awards Ceremonies.

## **The Canaries**



Time is an interesting thing. I would panic if you told me I had to get my blood drawn for 10 minutes. However, if you told me I could get a massage for 10 minutes, I would be disappointed.

If I had an upcoming flight and my ticket said it would take 31 hours to travel from St. Louis to South Florida, I would look for a new travel agent, but a 31-hour trip from St. Louis to South Africa sounds exciting.

So, was the year 1633 a long time ago? Compared to my time on Earth, yes. Compared to the dinosaur footprints I once visited in Bolivia, 1633 does not seem so long ago.

In February of 1633, Italian astronomer, philosopher, and mathematician Galileo Galilei was charged with heresy for suggesting – and believing – that the Sun stood motionless while the Earth revolved around it. As a result of this crime, Galileo spent the rest of his life under house arrest.

You read that correctly; just 400 years ago, a man was criminally charged for trying to help us see something differently.

The truth is, we have not evolved very much. As I work with teams in all industries, it is rare to find groups that allow individuals to share their perspectives openly. It is especially rare to find teams that welcome the voices of their newest team members.

I can confidently say that average teams don't value the experiences of their new members. Instead, they want individuals to acclimate to their culture before speaking up. In other words, they want you to become one of them before they value what you have to say.

Unfortunately, this ideology means losing the opportunity to learn from a fresh perspective. After a while, most of us find ourselves numb to the way things are done. Over time, we discover the window of opportunity to see and point out blind spots for others has closed, and this is precisely what average teams want. They have no desire to rethink their culture.

New team members have a unique perspective, and high-performing teams – unlike average teams – embrace and encourage that perspective.

I recently worked with a team whose head coach has won at every level. She is the best of the best. At the end of my visit, we sat in her office, and she said, “tell me everything I need to hear.” She craved a fresh perspective. I will admit, in moments like this, I work to suppress the voice within me that says, “But I just got here two days ago! What do I know?”

High-performing leaders and high-performing teams value different perspectives. Average teams require people to earn the opportunity to speak, and this is an element that keeps them average.

The clear eyes – those who have not yet given in to the “this is the way we do things here” mindset – function like canaries in a coal mine. For 75 years, canaries were taken into coal mines to help workers detect deadly invisible gases like carbon monoxide. The birds would show signs of distress and die long before humans could sense any danger. The behavior of a canary provided a clear signal of danger. They noticed what was toxic long before humans could.

Canaries were able to sound the alarm on what others did not notice. They literally saved lives. New team members can do the same. Unfortunately, average teams either silence the would-be canaries or allow them to depart to save themselves. In both cases, the opportunity for growth is missed.

Just 400 years ago, we were wrong. Collectively we believed the Sun revolved around the Earth, and sadly, we had no desire to consider other options.

What is happening within your team – committee, department, or organization – that in 400 years would seem ridiculous to an outsider? High-performing leaders will ask for the opinions of new team members early often. When we pay attention to new team members' behavior – including their distress – we can learn a lot.

Don't miss the unique opportunity to learn from someone your culture has not yet tainted.

Their perspective may be the very thing that saves you.
